



## LIMITED LIFETIME WARRANTY

Charger Water Treatment, LLC, 8150 Lehigh Avenue, Morton Grove IL 60053, warrants to the original purchaser of the Kenai water system that such Kenai water system shall be free of defects in materials and workmanship from the date of purchase for the average useful lifetime of the product. This warranty does not extend to any owner of the Kenai water system other than the original purchaser.

**IMPORTANT:** Purchaser must follow the maintenance requirements as outlined in the homeowner manual for warranty to remain in effect. Charger Water Treatment, LLC will not be responsible for any defects or damage to the system caused by the purchaser's failure to maintain the system.

This warranty is a LIMITED WARRANTY. The obligations of Charger Water Treatment, LLC hereunder and the original purchaser's sole remedy shall be limited to the repair or the replacement of the product or part only, at the sole and absolute discretion of Charger Water Treatment, LLC. TO THE MAXIMUM EXTENT PERMITTED BY APPLICABLE LAW, CHARGER WATER TREATMENT, LLC AND ITS OFFICERS, DIRECTORS, EMPLOYEES, AGENTS AFFILIATES, SUPPLIERS AND LICENSORS SHALL NOT BE LIABLE OR RESPONSIBLE UNDER ANY CIRCUMSTANCES OR IN ANY AMOUNT FOR ANY DAMAGES WHATSOEVER ARISING OUT OF THE USE OF THE PRODUCT, INCLUDING, WITHOUT LIMITATION, FOR CONSEQUENTIAL OR INCIDENTAL DAMAGES OR FOR INJURY OR DAMAGES TO PERSONS OR PROPERTY USING OR USED IN CONNECTION WITH THE PRODUCT, OR FOR LOSS OF PROFITS OR OTHER COSTS OR EXPENSES OF ANY KIND OR CHARACTER. THIS LIMITATION WILL APPLY REGARDLESS OF THE FAILURE OF THE ESSENTIAL PURPOSE OF ANY LIMITED REMEDY.

Labor charges incidental to the repair and/or replacement of parts other than factory repairs are expressly excluded from this warranty and the original purchaser must pay such charges. Transportation costs incurred in the receipt and installation of replacement parts other than factory repairs are expressly excluded from this warranty and must be paid by the original purchaser. This warranty shall not apply to any system which has been damaged by accident, fire, flood, act of God, abuse, neglect, freezing, unusual physical or electrical stress, misuse, or alteration, or installation or operation not in accordance with Charger Water Treatment, LLC instructions and applicable plumbing codes and ordinances. The Kenai water system is subject to normal wear and tear during its usable service life. Wear and tear is not regarded as a defect and is not covered by this warranty. Cosmetic damage is not regarded as a defect and is not covered by this warranty. This warranty covers the original product only and does not cover replacement filters or media.

How to make a claim on this warranty: Present this warranty to Charger Water Treatment, LLC at the address noted above. All claims must be presented within 30 days of occurrence of defect.
